Dear Ms. McClurg,

The ingredients selected to formulate the Teknor Color concentrate, 53,698HCP TR GREEN 50:1, are either “generally recognized as safe” (GRAS), prior-sanctioned, subject to an effective Food Contact Notification (FCN), or a Threshold of Regulation exemption (TOR), or identified in one or more of the following sections of Title 21 of the Code of Federal Regulations (CFR) published by the U.S. Food and Drug Administration (FDA):

- The ingredients selected to manufacture this compound are acceptable to contact food of all types under conditions of use C through H, except for articles used for packing or holding food during cooking as described in Table 2 of section 176.170(c).
